Feedstore<sup>®</sup> Hay Inoculant is a concentrated source of dried, live lactic acid-producing bacteria in a nutrient base to promote rapid microbial activity in baled alfalfa and all hay crops.

**Guaranteed Analysis:** Total lactic acid bacteria count not less than  $1.14 \times 10^{11}$  colony forming units (CFU) per gram (*Pediococcus pentosaceus*)

**Ingredients:** Sucrose, dehydrated *Pediococcus pentosaceus* fermentation product, sodium silicoaluminate, silicon dioxide, sodium bicarbonate, potassium sorbate, sodium diacetate, FD&C Blue No. 1 and FD&C Yellow No. 5.

**Mixing Instructions:** For best results, premix the contents of this package with one gallon of clean, chlorine-free water, and mix thoroughly. Mix this gallon of concentrated solution with 11.5 gallons more clean, chlorine-free water to make a total of 12.5 gallons (50 quarts). Solution

supplies 500,000 CFU per gram of treated hay. Wear gloves when handling. Use whole package at one time.

**Suggested Rates of Application:** Apply two quarts of mixed solution per ton of hay at the baler. Total solution will treat 25 tons. Hay must be baled when the moisture content is 18 to 23 percent (absolute min./ max. is 16 to 25 percent).

**Storage and Handling:** Store unopened packets in a cool, dry place. Refrigeration at 40°F (4°C) is recommended. Avoid leaving bag open. Shelf life is 18 months from date of manufacture when stored as recommended. Hay Inoculant is a natural, biological product. It is non-corrosive and generally regarded as safe to use.

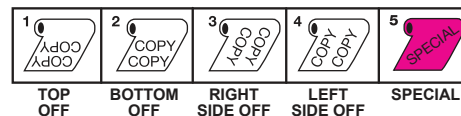
