Use Home Run[™] with post-emergent pesticides, especially herbicides. It improves a spray application by physically modifying the deposition and wetting characteristics of the spray solution, resulting in a more uniform spray deposit.

Mixing Instructions:

To minimize the potential for foaming, fill the spray tank two-thirds full of water. Add pesticides and/or fertilizers as directed by the label, or in the following sequence: micronutrients and fertilizers, dry flowables and dispersible granules, flowables, water soluble pesticides and then emulsifiable concentrates. Continue agitation and add Home Run. After the addition of Home Run, reduce agitation and allow to mix for one to two minutes. Continue filling tank while continuing minimal agitation.

Keep from freezing.
