Volume Qualifications

Independent Distributors/Preferred Contractors who have earned the Preferred Contractor title are invited to attend the Preferred Contractor Destinations trip.

Qualifying Silver, Gold, Sterling, Platinum, Diamond, and Honorary Gold Preferred Contractors

- Will receive an invitation to attend the Preferred Contractor Destinations trip paid by Conklin.
- The package includes:
 - Deluxe resort accommodations.
 - Program meals and scheduled program breaks for up to two adults.
 - Special apparel and gear available exclusively to attending Preferred Contractors.
- Travel to and from the destination will be the responsibility of the attendee.

Honorary Silver and Emeritus

- Will receive an invitation to attend the Preferred Contractor Destinations Trip at their own expense.
- Special package pricing will be available and will include:
 - Deluxe resort accommodations.
 - Program meals and scheduled program breaks for up to two adults.

- Travel to and from the destination will be the responsibility of the attendee.

2026 Preferred Contractor Destinations Trip

Trip Rules and Guidelines

- The Preferred Contractor Destinations trip is open to qualifying Preferred Contractors, spouses/guests and qualifying Legal Business Partners, if applicable. (Proof of 33% or higher business partnership is required if the attending Preferred Contractor plans to include a Legal Business Partner in attendance of the trip and the business session.)
- **An invitation email and letter with instructions for online-only trip registration will be sent to all qualified Preferred Contractors soon after the qualification period ends. Online trip registration for the qualified Preferred Contractor must be submitted no later than the date specified in the invitation email and letter or the trip will be forfeited.**
- The Preferred Contractor Destinations trip is only valid for the dates scheduled.
- The Preferred Contractor Destinations Trip has no cash redemption value. If a qualifying **Preferred Contractor (Gold Level or above)** chooses not to attend the trip, it may be exchanged only for the **2027 Conklin National Convention Package**, which includes:
 - Two (2) registration fees
 - Three (3) nights lodging/accommodations
 - Two (2) Gala Banquet ticketsTo exercise this option, you must register for the 2027 Conklin National Convention and select the registration type: *Turning in Preferred Contractor Destinations Trip* for both you and your spouse or legal business partner.
Lodging arrangements and Gala Banquet tickets must be booked and purchased by the attendee. After attendance is confirmed following the convention, a **\$625 deposit** will be made into your Convenience account.
- Only one (1) Preferred Contractor Destinations trip may be earned during the qualifying period.
- Conklin reserves the right to withhold or withdraw the Preferred Contractor title and trip for any individual whose account is overdue at any time during the qualifying period.
- Meals and activities not specified in the program will be at the traveler's expense. This includes pre- or post-trip extensions.
- Conklin will issue a 1099 tax form to the qualifying Conklin identification number for the Destinations trip.
- All qualified Preferred Contractors attending the Destinations trip are fully responsible for travel costs and arrangements to/from the trip location.
- **Cancellation 30 days or less prior to travel to the Preferred Contractor Destinations trip will result in a substantial cancellation fee.**
- Conklin Company reserves the right to make changes to this program at any time without notice.
- First-Year Preferred Contractors
 - **First-year Preferred Contractors are eligible to achieve up to the Gold level.**
 - First-year Preferred Contractors are eligible to achieve at the Silver or Gold levels only. Please refer to 2027 Preferred Contractor Program documents for more information on requirements for Advanced Levels.
