SECTION 4 - FIRST AID MEASURES

EYES: Immediately flush the contaminated eye(s) with clean, lukewarm, gently flowing water for 15-20 minutes, while holding the eyelid(s) open. If a contact lens is present, DO NOT delay irrigation or attempt to remove the lens until after flushing is complete. Take care not to rinse contaminated water into the unaffected eye or onto the face. Immediately obtain medical attention.

SKIN: Remove contaminated clothing, shoes, and leather goods (e.g. watchbands, belts). Flush with lukewarm, gently flowing water for 5 minutes. If irritation persists, repeat flushing. Obtain medical advice. Completely decontaminate clothing, shoes, and leather goods before reuse, or discard.

INGESTION: Never give anything by mouth to a victim who is rapidly losing consciousness, is unconscious, or is convulsing. Have victim rinse mouth thoroughly with water. Do NOT induce vomiting. SECTION 7 - HANDLING AND STORAGE

STORAGE TEMPERATURE: Store above 40°F and below 100°F.

HANDLING AND STORAGE PRECAUTIONS: Do not freeze. Use personal protection recommended in Section 8. Open containers slowly in case of pressure accumulation. Protect from direct sunlight. Store in dry, cool, ventilated area in tightly closed containers out of the reach of children. Do not store on side. Avoid creasing or impacting container sidewalls. Empty containers may be hazardous. Do not eat, drink, or smoke in chemical use or storage areas. Wash hands after handling and before eating, drinking, or smoking. Do not rub eyes with soiled hands. SECTION 8 - PERSONAL PROTECTION/EXPOSURE CONTROLS

ENGINEERING CONTROLS: Provide sufficient general and local exhaust ventilation to maintain safe exposure levels. Take measures to minimize exposure. Provide a source of clean water for flushing eves and skin.
